# Subject:OCTOBER 2011 update on recent agricultural commodity and food<br/>price developments in the EU (based on September 2011 prices)

### 1. Development in agricultural commodity prices

September 2011 revealed new record prices for beef (€355/100kg carcass weight) and poultry meat (€199/100kg carcass weight). The sluggish annual increase in cereal prices continued.

*Monthly developments:* September 2011 depicted a mixed picture on EU price developments for the selected agricultural commodities: while prices for some of them increased further: durum wheat (+8%), soft wheat, barley and poultry (each category by +3%) and beef meat (+2%), the quotations for maize, cheese (Edam) and pork meat exhibited a negative trend (-12%, -2% and -1% respectively). Skimmed Milk Powder and butter prices remained stable. (cf. Table 1).

Tel. direct line (32 2) 29 93527 *Year-on-year developments:* September 2011 brought higher prices than one year ago for all the products except soft wheat whose price remained unchanged. Although the sluggish annual increase in cereal prices continued, the selected agricultural commodities registered further price increases: durum wheat (+44%), maize and poultry meat (+11%), barley (+15%), SMP (+2%), butter (+9%), cheese (Edam) (+5%), beef (+12%) and pork meat (+7%). (cf. Table 2, Graphs A2, A3 and A4 in annex).

### 2. Development in consumer prices

In September 2011<sup>1</sup>, the monthly rate of food price inflation maintained at the level of last month while the overall inflation increased by 0.6%. The annual rates for both food price and overall inflation increased, with food price inflation lagging behind the overall inflation (+2.9% as opposed to 3.3%) (cf. Tables 3 and 4 and Graphs 1 and 2).

With the exception of "Fruits" (-1.1%), "Vegetables" (-0.9%) and "Other food" (-0.2%), all the other food categories recorded further price increases in September 2011 as compared to one month before: "Fish and seafood" (+0.5%) being the category with the highest increase rate.

When compared to one year ago, apart from the "Fruits" and "Vegetable" categories whose prices declined by -0.2% and -5.1% respectively, all the other consumer food prices showed higher levels, notably for the "Oils and fats" (+7.6%) and "Sugar" (+5.2%) categories.




#### 3. Overall and food inflation against energy inflation

In September 2011 the energy consumer price increased by 0.7% when compared to one month ago (cf. Graph 1) and was 11.8% higher when compared to the previous year (cf. Graph 2).



Graph 1 Monthly rate of change in overall, food and energy inflation (%, January 2007 until September 2011)


Graph 2 Annual rate of change in overall, food and energy inflation (%, January 2007 until September 2011)



Graph A1: Overall and food price inflation against energy inflation in the EU (January 2000 until September 2011, Jan2000=100)






### Graph A2: Cereals/bread and cereals based products: EU agricultural market and consumer price developments (January 2000 until September 2011, Jan2000=100)





